

(i) **Breach of section 185 (2)**

"ELECTION BOMBSHELL - LNP candidate sets up her election campaign as a business with an ABN."

A website with the domain name of www.dontwalkpast.com.au was created.

An ABN was registered in the name Don't Walk Past, to stop anyone else from using or operating this business name while my website was operational.

No business was operated under this name, no bank account was set up, and no financial transactions occurred.

Registering an ABN does not create a legal obligation to actually operate a business under that name.

(ii) **Breach of section 185 (2)**

"When applying for an ABN you are required to declare where you are getting an income from."

This information is factually incorrect. You are not required to declare where you are getting an income from when you register an ABN.

(iii) **Breach of section 185 (2)**

"How can you make an income from an election?"

Mr Brown infers the ABN had been set up in order to make an income from the election.

(iv) **Breach of section 185 (2)**

"I'll be writing to ASIC, the ATO and ECQ to investigate".

This statement infers a candidate having an ABN is improper, and that the Australian Securities and Investment Commission, the Australian Tax Office and the Electoral Commission of Qld would need to investigate as a result.

I believe if these organisations are contacted, no such letters from Mr Brown would exist, and that this statement is knowingly false.

(v) **#peoplebeforeprofits**

Mr Brown infers that by registering an ABN, I have put profits before people.

On the evening of Sunday 25 October, I received a Private Message from Don Brown MP.

I believe this Facebook Post was a deliberately pre-planned and orchestrated attempt to discredit me, 2 days prior to the election.

I was alerted to this post when I was standing at pre-poll handing out how-to-vote cards.

I did my best to send off replies to try to discredit the information he had placed online, however I was limited in my ability to do so as I was interacting with voters at pre-poll at the time.

My own 13 year old daughter said "mum – if I didn't know you and I read this, I would think you were corrupt."
